- Bidder will be bound to deliver the ordered items at VU Head Office Lahore within 30 days from the issuance of purchase order.
- Virtual University of Pakistan (VU) reserves the right to increase or decrease the quantity of Goods specified above at the time of issuance of purchase order. VU also reserves the right to place the order on partial shipment basis.
